1 Overview

A Background

The 2025 LIP program year is January 1, 2025, through December 31, 2025. The signup period began January 1, 2025. The deadline to complete 2025 LIP applications is March 2, 2026. LIP provides separate payment rates for eligible livestock owners and eligible contract growers. Payment rates for lost eligible livestock that are owned or contract grown are included in this notice.

B Purpose

This notice:

- provides updated 2025 LIP per head payment rates for the specific kind, type, and weight for eligible livestock owners and contract growers
- informs State and County Offices that payment rates for livestock owners are based on 75 percent of the average fair market value, as determined by CCC, for the specific kind, type, and weight of livestock
- informs State and County Offices that payment rates for livestock contract growers are based on 75 percent of the national average income loss sustained, as determined by CCC, for the specific kind, type, and weight of livestock.

2 2025 LIP Payment Rates

A Overview

The 2025 LIP payment rates are established through the Economic and Policy Analysis Division as required in 7 CFR Part 1416.306, Subpart (b). These rates have been loaded into the LIP software to calculate program benefits after applications have been approved. LIP benefits must be calculated according to 1-LIP.

B 2025 LIP Payment Rates for Eligible Livestock Owners

Payment rates for livestock owners are based on 75 percent of the average fair market value, as determined by CCC, for the specific kind, type, and weight of livestock. The following table provides LIP per head payment rates, by livestock category, for eligible livestock owners.
